The Swannanoa Valley Fine Arts Exhibit at Black Mountain Center for the Arts will open on November 7, 2008 with a reception from 6:00 to 8:00 pm. Members may enter 1 piece in the exhibit from the following categories (please note some changes in the categories):

- 1. Oil/Acrylic Media**
- 2. Watercolor Media (Yupo or canvas, including watercolor, gouache, watercolor pencil, casein, egg tempera)**
- 3. 3-D (sculpture, glass works)**
- 4. Other (graphite, printmaking, pen/ink)**
- 5. Photography and Computer Art**
- 6. Fiber, Paper, Collage**
- 7. Pastel**

Judge The judge for this exhibit is Wendy Outland. Wendy received her Bachelor of Fine Arts degree from Ringling School of Art & Design. She was employed by the Florida Department of State for ten years, initially at the John & Mable Ringling Museum (The State Art Museum of Florida) in Sarasota, where she began as Curatorial Specialist and became Assistant Registrar (1981-1985). A promotion within the Department of State took her to Tallahassee, where she worked for the Florida Arts Council administering the state public art program as well as the Capitol Complex Exhibition Program (1985-1991). Ms. Outland then moved to North Carolina and became manager of Blue Spiral 1, a premier three-level, 14,000 sq. ft. gallery in Asheville (1991-2003). Ms. Outland has worked in arts administration for twenty-six years and has been editor, grants panelist, presenter, juror, and curator for numerous projects and events. She has served on the board of the Asheville Area Arts Council and currently serves on the boards of the American Craft Council – Southeast Region and Handmade in America. She presently has her own business, Who Knows Art, a consulting firm to visual artists and arts organizations.

Entry Fee \$15 per entry (non-refundable).

Rules

1. Exhibit for members only with up-to-date membership (\$30.00 payable July 1). You may pay on entry day if not already paid.
2. Size restriction: no wider than 36" framed.
3. Must be original work - not a copy and completed within the last two (2) years. Paintings using another's photo reference must have permission of photographer and be noted on entry form.
4. **NO CLASSROOM WORK WILL BE ACCEPTED!**
5. Professional presentation required. Only framed work, clean mats, wrap-around canvas, will be accepted. Must have secure wire across back; no sawtooth hangers. Unframed works must have painted edges.
6. Work cannot have been exhibited in a previously juried SVFAL show.
7. Work accepted/rejected at the discretion of the committee or judge, including subject matter and presentation.
8. Artwork must be left in place for the duration of the show. Early removal forfeits entry into future SVFAL shows for one (1) year.

Liability Neither the SVFAL nor the Black Mountain Center for the Arts will be responsible for loss or damage to entered pieces, although every effort will be made to protect them.

Sales 30% of sales will go to Black Mountain Center for the Arts.
